PSI Ends a School Year but Begins Exciting Initiatives

TESOL Services at Several PSI Schools Some reasons to be grateful if you grew up speaking English:

The bandage was wound around the wound. The farm was used to produce produce. The dump was so full that it had to refuse more refuse. The soldier decided to desert his dessert in the desert. Or pronunciations in the English language can be a challenge! For example, if you have a rough cough, climbing can be tough when going through the bough on a tree!

But help is on the way...

This year marks the beginning of PSITESOL services. TESOL or Teaching English to Speakers of other Languages, is to help English Language Learner (ELL) students overcome linguistic, cultural, and language difficulties to assure they receive an equal educational opportunity. Research suggests that it takes one to two years for a student to develop conversational English skills in speaking and listening, but about five to seven years to develop proficient reading and writing skills in English. The age of the child and literacy in the native language also play an important role in English language acquisition. For those students who qualify for the TESOL program, sessions focus on the Ohio English Language Proficiency Standards in the areas of Listening, Speaking, Reading, and Writing. Students will continue to receive services until they reach English proficiency. A required annual state test called the Ohio Test of English Language Acquisition (OTELA) is administered to all students who are Limited English Proficient in the spring of each year. This test must be given to all students who are not proficient in English, regardless of whether parents accept or decline TESOL services for their child. While public school districts are responsible for the identification and other services for LEP (Limited English Speakers) services, private schools must check with their public school district for direction. PSI has hired several teachers this school year and are looking toward expanding these services next school year. Eat a Rainbow!

PSI's own Kelly Hickey and her sister Kris Rosenfeld have developed the Eat a Rainbow Make Your Body Smile program. This program integrates nutrition and health education while teaching children to take care of their bodies and the planet. In partnership with PSI, a pilot program was recently completed at St. Mary of the Falls School in their Kindergarten through 3rd grades." Just knowing the five colors of a tweaked rainbow provides a very basic, visible cue that was very

easily associated with fruits and vegetables," Rosenfeld says."The model that we came up with is designed to be a self-monitored approach to good nutrition." As PSI already has staff in numerous schools in the areas of health and prevention, it is a natural extension to include an awareness of healthy eating habits. This, coupled with Michelle Obama's Childhood Obesity Task Force, makes this new PSI initiative one that will certainly be helpful to our partner schools.

What Works

This month we are lucky to have two PSI staff members contribute educational strategies that have proven successful with their students. Thank you to Lee Knox and Suzanne Vitanza for sharing!

Research-Based Reading Interventions by Lee Knox, M.A., CCC-SLP

The PTO of St. Paschal Baylon School, where I provide Speech and Language services, graciously allocated some funds this school year to be used for intervention materials. In the process of doing hours of research to find materials, I came across this outstanding resource from the Florida Center for Reading Research.

It fit all of the criteria I was looking for: that it be researchbased; that it targeted our areas of need; be easy to use; and beneficial to as many of us as possible (Intervention Specialists and SLPs); as well as cost efficient.

Our PTO was agreeable to using some of the allocated funds for printing the material. I was able to download all of the files from the website, copy them to Bridgette Reed's (Intervention Specialist) flash drive, and take them to be printed. We then assembled the pages into binders for each of the Five Big Ideas of Reading for grades K-5.

We now have a great library of research-based, supplemental intervention materials for phonemic awareness, phonics, fluency, comprehension and vocabulary, each in their own binder, for each grade level. And the best part, it was all free material (minus the printing cost).

I found a reasonable cost at a local printer, at a fraction of the cost that workbooks of that many pages would amount to! (It paid to get estimates, as prices varied widely among the 7 printers I called!) Since we use DIBELS at our school, these materials follow along with the 5 big ideas! Positive Performing People by Suzanne Vitanza, Intervention Specialist

Positive Performing People is an excellent behavior strategy that I use in my classroom for my learning disabled students. I implemented it at beginning of the school year with my third and fourth grade classes. This approach focuses on the positive behavior of the student, not the negative and has proved to be a success! First, above a pocket chart, display **POSITIVE PERFORMING PEOPLE** in bold, bright colors. Next, each student is given a'punch card'. This card can be bought or self-made. The message, 'Good Job' is labeled on the top of the card with a line underneath for the student's name. Fifteen happy face stickers outline the card.

How the Card Works: The student is given a 'punch' on the card when he or she displays a positive behavior. The 'punch' is made with either the teacher's initials or a decorative hole puncher.

For example, the student has his or her materials out and ready without being told; participates in class more than usual; raises hand before speaking, etc. The student is rewarded when they have earned fifteen punches on their card. The student is given the choice of a prize from either the 'treasure box' or a homework pass. The prizes can be a candy bar, book, children's magazine, puzzle book, etc.

The *Homework Pass* is a coupon for no homework that day; however, the student does need approval from the teacher before using.

From the Desk of Janet Yue Health Services Manager

May 12th was National School Nurses Day! On behalf of the entire staff at PSI, we would like to take this opportunity to recognize and thank all PSI nurses for their service. Whether you supervise a district, work at your assigned school, or help us by substituting, we appreciate all you do to keep children healthy and ready to learn.

As the school year comes to a close, there are several matters of importance that need to be shared with our Health Service Staff:

The opportunity to be recertified for CPR and First Aid will be offered over the summer. The classes will be offered by PSI and are free. Once again, Mary Flanagan will be teaching our classes. Any employee whose certifications are due to expire this summer or early fall should plan on attending. You will receive a schedule of classes in the mail. Registration may be limited due to space. You are always welcome to take a class at a more convenient location but we will need copies of your cards and your receipt to be reimbursed if you take it from a different provider.

PSI plans to offer a House Bill 276 training- a four hour inservice training program in the prevention of child abuse, violence, and substance abuse and the promotion of positive youth development. This is a requirement of the State of Ohio. All licensed nurses who have yet to complete this four hour in-service must do so within 2 years of their employment with PSI. Health Aides are not required to attend but are strongly encouraged to complete this training. For those who have not yet met this requirement, you will receive details on the **August 20, 2010 training**. If you have attended this class, given by another provider, please send your documentation to PSI.

PSI will be mailing to all Health Service Staff a packet of information regarding daily documentation of student health visits. In the past we have used a daily log listing each student. The Ohio Department of Health, for confidentiality reasons, now requires us to create an individual daily log. **The new Individual Clinic Visit Record** and instructions will be mailed to your home. We will no longer use the Daily Log and we are asking that you remove the Daily Log and replace it with the new Individual Clinic Visit Record. The Individual Clinic Visit Record provides a uniform, continuous record of a student's visits to the health clinic and it documents the nursing process. This health clinic visit information becomes part of the student's individual health record. Please call with any questions.

Over the summer, the Health Resource Guide will be updated with pertinent information that is either added or revised. This mailing will be sent to all staff prior to the start of the school year. Please review and add the material to the Guide. If you have borrowed equipment or videos please contact the office so we may assist you in their return.

Anyone who has not completed Tentative Plans, please complete and return them. If you have misplaced this form or didn't get one please call us and we will forward a copy to you. Prior to the end of school, please check with your principal or check your school calendar for the date of opening day for your school for the 2010-2011 school year. Our work assignments do not tell you what day school begins.

Work Assignments will tell you the school's name and the hours allocated for work per year. These usually are mailed from the PSI Office to your home in late August.

We will be mailing contracts to employees in early summer. Please mail your signed copy back to us promptly. This is very important to us as we make assignments for the opening school year.

We would like to take this opportunity to wish two long-term nurses and one health aide a Happy Retirement. Judy Armstrong has been with PSI since 1989 and Chris Hippely has been with us since 1995. Lynn Milia has been a PSI Aide since 1997. Thank you for your years of service. We wish you a wonderful retirement.

Prevention/Intervention News

• After 22 years, Congress has eliminated the states' grants portion of the Safe and Drug Free Schools and Communities funds. This grant source had funded the Diocese of Cleveland consortium that allowed each school to choose a Prevention/Intervention program yearly. As a service provider, PSI collected data and was able to exhibit the effectiveness of its Prevention/Intervention programs, but Congress felt that many recipients of the grant had not done the same, and therefore chose to re-allocate this funding.

We at PSI continue to feel a commitment to the children in the Diocese of Cleveland and their need for anti-drug and anti-violence programs and it is with sadness that we face this program elimination. While funding is an issue during these challenging economic times, we will strive to find creative means to continue our programs.

Some options are:

- -Utilizing alternative funds such as PTO/PTA for the original or shortened versions of these programs.
- -Providing classroom teachers or other school staff with training in implementing our programs.
- -Possibly supplementing other PSI services with Prevention Services.
