10 Great Tips for a Successful 2016

As a PSI employee, there is always so much to learn for your current position or for the future... <u>Body language</u> can be your greatest career asset. Here are ten simple and powerful tips to help you have a super successful 2016.

1. To make a great first impression, begin before you enter the room.

In business interactions, first impressions are crucial. Once someone mentally labels you as "likeable" or "untrustworthy, "powerful" or "ineffectual," everything else you do will be viewed through that filter. If someone likes you, she'll look for the best in you. If she mistrusts you, she'll suspect devious motives in all your actions.

A study at the <u>University of Glasgow's Centre for Cognitive Neuroimaging</u> discovered it takes the brain just 200 milliseconds to gather most of the information it needs from a facial expression to determine a person's emotional state. That's why you can't wait until you're in the meeting room to "warm up." You've got to walk in, already expressing the emotions you want to project.

2. To increase your professional impact, make eye contact like Goldilocks.

Too much eye contact is instinctively felt to be rude, hostile and condescending; and in a business context, it may also be perceived as a deliberate intent to dominate, intimidate, belittle, or make the other person feel at a disadvantage. Too little, on the other hand, can make you appear uneasy, insincere, or uninterested.

In its analysis of patients' complaints, for example, one large county hospital found, that 9-out-of-10 letters included mention of poor doctor-patient eye contact; a failure which was generally interpreted as "lack of caring." (To improve your "too little" eye contact, make a practice of noticing the eye color of everyone you meet.)

"Just the right" amount of eye contact – the amount that produces a feeling of mutual likability and trustworthiness – will vary with situations, settings, personality types, gender and cultural differences. As a general rule, though, direct eye contact of about 60% of the time during a conversation – more when you are listening, less when you are speaking – makes you seem attentive, interested and informed.

3. To boost your self-confidence, ditch your cell phone and buy a newspaper.

You may be familiar with research from Harvard and Columbia Business Schools about the effects of expansive physical poses — feet wide apart, body erect, hands on hips (think "Superman" or "Wonder Woman"). Studies show that holding this kind of "power pose" for just two minutes raises testosterone levels (the hormone linked to power and self-confidence) and lowers the level of cortisol, a stress hormone.

But did you know that this hormonal effect is actually reversed when you tuck your chin in, round your shoulders and contract yourself physically? In that posture, you lower your testosterone level – and its corresponding feelings of confidence – while increasing cortisol.

So, instead of hunching over your smart phone, try leaving it in your purse or briefcase while you wait in the lobby for an upcoming meeting. Instead, take out a newspaper, and read it sitting up straight with your feet firmly on the floor, and your arms spread wide to hold the paper open. By putting your body into this expansive posture, you will not only feel more confident and certain when the meeting starts, you will also be perceived that way.

Although this screening is not required by the ODH, it is recommended for students in grades 5, 6 and 7. Check with your building administrator if you are unsure if your school conducts this screening.

If your school will be conducting kindergarten screenings this school year (for the upcoming school year) and Vision and Hearing Screenings are performed, please make sure that you have the necessary screening equipment.

RN's and LPN's are entitled to Professional Development days as outlined in the attendance policy. In order to ensure adequate coverage in your area, pre-approval is required from the Health Services Administrative Team.

Make sure to check your Time Remaining forms. If you find there is a discrepancy, contact Nancy Berlan at extension 238.

Important Updates

Tentative Plans for the 2016-2017 school year will be going out electronically in March. Please fill these out and return them to us as soon as possible so we can best accommodate any anticipated changes.

Remember to check your psi-health email regularly. All staff are notified via email when updates are made to the Health Intranet, including the online Health Resource Guide and Commonly Used Forms. Please make sure that the hard copy of the Health Resource Guide binder in your clinics is updated also. Don't forget to update forms in your files as well. Check the Bulletin Board on the Health Intranet as well for information and updates.

Ohio HB 39 went into effect on February 1, 2016 and allows schools to procure inhalers for use in emergency situations when a person exhibits signs and symptoms of asthma. We will notify all staff when the ODH provides information regarding the staff training requirements.

New meningococcal immunization requirement for grades 7 and 12. Beginning with the start of the 2016-2017 school year, all pupils entering the 7th and 12th grade are required to be vaccinated against meningococcal (serogroups A, C, W, and Y) disease. One (1) dose of meningococcal (serogroups A, C, W, and Y) vaccine is required prior to entry into the 7th grade.

A second (2nd) dose of meningococcal (serogroups A, C, W, and Y) vaccine is required prior to entry into the 12th grade. The second (2nd) dose must be administered on or after the 16th birthday with at least eight (8) weeks between the first (1st) and second (2nd) dose. If the first (1st) dose of meningococcal (serogroups A, C, W, and Y) vaccine was administered after the 16th birthday, a second (2nd) dose is not required. If a pupil is 15 years of age or younger, only one (1) dose is required.

The ODH Immunization Department clarified that any Meningococcal vaccine that was received before 10 years of age does NOT count toward this requirement.

All immunization charts, forms and letters have been updated on the Intranet in the Immunization section of the Health Resource Guide and in the Commonly Used Forms Section.

The 2015 Hearing Screening Guidelines and Requirements (effective in the 2016-2017 school year) have been published and can be found on the ODH website. In addition to the grades currently being screened, the requirements now include hearing screening for all 11th grade students.

Medication Administration Reminder

The Six Rights of Medication Administration are the standard safety procedures that must be followed by all people who administer medications. When the procedure is followed, the opportunity for a medication administration error is significantly reduced. The procedure includes checking the "six rights" of medication administration, each time medication is administered.

- Right Student
- Right Medication
- Right Dose
- Right Time
- Right Route
- Right Documentation

You will soon receive Tentative Plans forms for the 2016-2017 school year.





X-Out Bullying at SFX

With the help of PSI's Toula Barlow, Ph.D., students at St. Francis Xavier are saying no to bullying.

Evan is currently an 8th grade student at St. Francis Xavier School (SFX), located in Medina, Ohio. In October of 2015, he expressed an interest in bringing bullying awareness to SFX. As a student who experienced bullying himself, Evan had a desire to make a difference in his school, with the hope that his efforts would continue after his graduation in May of 2016. Evan came up with a plan, recruited some of his friends, pitched his idea to the principal, Mrs. Bibiana Seislove, and "X-Out Bullying" was formed.

Once per month, under the guidance of PSI's Dr. Toula Barlow and Broadcast Director, Mrs. Mindy Woll, the X-Out Bullying team broadcasts a message to the student body, defining an aspect of bullying, such as physical, verbal, cyber, etc., and teaches the students how to handle conflict. At the end of their broadcast, they challenge students to make a positive change in their school.

To further their cause, they have incorporated "Wear Blue" days which are held once per month. Students are asked to support the program by dressing down (blue t-shirts and tennis shoes) for a donation of .25 to .50 cents. As a thank you, the team has provided donated pencils, positive message bracelets and book marks to those dressing down in support the X-Out Bullying program. Proceeds from "Wear Blue" days go back to fund programs, including LifeAct (a suicide prevention program) and SFX student Council's Rachel's Challenge (geared at motivating, educating and bringing positive change to youth). In two months, the X-Out Bullying team has raised \$435.71 for their cause. To continue keeping students engaged, the classroom with the most donations at the end of the year will be treated to a pizza party!

These 8th grade students have stepped up in an effort to bring positive change to SFX, being fully aware of the possibility of being targeted/teased about such an endeavor. In the next month, they will be introducing the "Xperience" box where students can anonymously share their experiences related to bullying, both positive and negative; selling of X-Out Bullying t-shirts; and engaging other students by working together to create posters with positive messages for display throughout the school.

ALERT for SLPs, OTs, and PTs: Medicaid Reimbursement Changes for Schools

The Center for Medicare and Medicaid Services has announced a change concerning the Medicaid Schools Program that will affect how schools are able to submit for reimbursement. By August 1st 2016, schools must have an order, referral, or prescription for speech and language therapy, occupational therapy, or physical therapy by a physician or licensed practitioner of the healing arts if they would like to receive reimbursement from the Medicaid Schools Program. It is important to point out that students are still able to receive these services via an Individualized Education Program with or without an order, referral, or prescription. It is not anticipated that this change will affect your role in the schools, but it is important to be aware of this as you may start to hear your coordinators discussing how they will adhere to these new mandates.

NEW Workload Calculator

The Office for Exceptional Children just released a tool to help schools make decisions about the workloads of service providers in special education. We encourage you to try out the calculator with your current workload. If you think that you may need more time in your building in order to appropriately service your students, this tool may be a great way for your Field Supervisor to advocate for this change. It is important to note that this calculator is not the only way that schools calculate workloads, but it is a valuable method to be aware of. HQT Changes

At the beginning of the 2016-2017 school year, Intervention Specialists of students in grades 7 through 12 who participate in the Alternative Assessment for Students with Significant Cognitive Disabilities will be required to meet highly qualified teacher status. Please ensure that you have earned or have plans to complete the requisite 45 contact hours of core content for the needed subjects. Check out your regional State Support Team for HQT courses being offered. If you have any questions or concerns, please contact your Field Supervisor.
